The DD Waiver is a Home and Community-Based Services Medicaid Waiver for people with Intellectual and Developmental Disabilities. The DD Waiver is a person-centered, community oriented approach to supporting people to live the life they prefer in their community. The DD Waiver must follow state and Federal rules and requirements and the DD Waiver Service Standards.

ELIGIBILITY

- Have an intellectual disability (ID) that was acquired before reaching 22 years of age.
- Have a related condition (Including but not limited to; autism, cerebral palsy, Down syndrome or other qualifying diagnoses)
